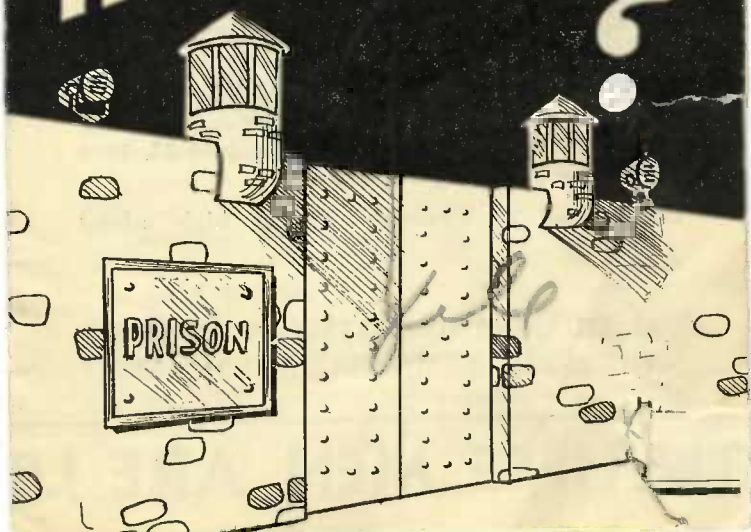

WHO SPREADS NAZI-INSPIRED PROPAGANDA?



JOHN ZITTER

Former Captain of the Christian Mobilizers' Guard Unit and presently a Mobilizer street speaker.

Zitter, as a street speaker for the Christian Mobilizers, delivers inflammatory Nazi-styled speeches designed to incite racial-hatred and civil-strife. WE ASK—How can John Zitter represent a group which hides behind the name Christian? A group which proclaims itself to be pro-Democratic and yet teaches ideologies identical to those fostered by Hitler.

THIS IS HIS RECORD

Criminal Background—November 3, 1934 arrested for burglary. Later he and his accomplice admitted the commission of four other burglaries during the 2½ month period prior to his arrest. December 4, 1934 his sentence was suspended at a court of General Sessions, and he was placed on probation for a period of two years.

August 26, 1939 served with court summons for inflammatory speech delivered August 25, 1939 at a street meeting in the Bronx.

Educational Background—Partial high school training.

IS THIS PERSON FITTED TO INSTRUCT THE PUBLIC ABOUT TRUE AMERICANISM?



JOHN J. OLIVO

Captain of the Christian Mobilizers' Guard Unit.

Olivo, as Captain of the Mobilizers' Guard Unit, trains the young followers of United Hate Front Leader Joe E. McWilliams in jui jitsu, boxing, wrestling, street-fighting tactics, drilling and rifle practice. Olivo has also served as a speaker for the Christian Mobilizers.

WE ASK—Is John Olivo morally qualified to train American youths? Is John Olivo mentally equipped to mold public opinion as a platform speaker?

THESE ARE HIS QUALIFICATIONS

Moral Characteristics—January 14, 1931 John Olivo was committed to a Children's Court as a delinquent after he had been arraigned for stealing an automobile

October 11, 1934 he was arrested for attacking and raping a woman in Central Park—then fleeing with the contents of her purse. Sentenced to the Penitentiary on December 10, 1934.

Although married, he has made no effort to maintain a home for his wife.

Physical Characteristics—Treated at Bellevue Hospital for venereal disease.

Mental Characteristics—His psychiatric report shows that he is an emotionally immature type of personality deviate, and that he has neurotic tendencies of moderately complicated nature. Formal Education—Public School No. 37—during which schooling his conduct and scholastic work were of a low order.



EDMUND VINCENT BURKE

Platform and street speaker for the Christian Mobilizers.

As a Mobilizer speaker, Burke praises Hitlerian principals, damns the Jews, and fosters an economic battle against Jewish business, the press, radio and movies. He frequently serves as Chairman during the absence of McWilliams.

WE ASK—How long will the public tolerate hate-instilling speeches whose purpose is the undermining and destruction of its Constitution and Bill of Rights? Does Freedom of Speech incorporate the privilege of slander and incitement to riot?

THIS IS BURKE'S BACKGROUND

Criminal Record—August 31, 1926 Burke was arrested for breaking and entering a jewelry store and stealing a tray containing a number of white gold diamond rings, several platinum mounted diamond rings, six wedding rings and eighteen bracelets.

Physical Record—An examination indicated that he was retarded mentally.

EDWIN WESTPHAL

Member of the Advisory Board of the Christian Mobilizers and member of the German-American Bund.

Westphal has also appeared on the platform of the Crusaders for Americanism and as one of the most vicious speakers among the pro-Nazis stated, "What we need here is another Hitler or Franco."

THIS IS HIS RECORD

November 21, 1929—Indicted for burglary, second degree; grand larceny, second degree and receiving. Pleaded guilty to burglary in third degree, sentenced December 13, 1929.

September 27, 1929—Arrested for burglary but witness (his step-father) relented and withdrew charge.

July 14, 1930—Convicted at 5th Dist. Court, Queens, as wayward minor. Sentenced to N. Y. State Reformatory.

February 17, 1937—Convicted of violation of Copyright Law. Sentence suspended.

July 1, 1937—Convicted for violation of Copyright Law. Sentenced to 60 days, sentence suspended.

August 13, 1939—Convicted on disorderly conduct charge. Sentenced to six months probation.

JOSEPH HARTERY

Street speaker for the Christian Mobilizers.

THIS IS HIS RECORD

January 7, 1932—Arrested under name of Joseph Herman. Charged with offering or agreeing to receive two persons for purpose of prostitution, lewdness and assignation. Pleaded guilty and sentenced to 30 days.

December 21, 1934—Discharged from work for attempted attack on fellow worker with an ax.

December 14, 1938—Arrested for threatening a man with a clasp knife. Sentenced to three days in workhouse.

February 14, 1939—Arrested for defacing seats in courtroom. Sentence suspended.

August 31, 1939—Fined \$10 for statements made at street meeting.
